CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A WELL in the PUDDING RIVER BASIN for the purpose of IRRIGATION OF 119.5 ACRES.

This right has been perfected under Permit G-8614. The date of priority is NOVEMBER 20, 1978. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.43 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the well.

The well is located as follows:

NE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 67, SECTION 24, T 7 S, R 2 W, W.M.; 650 FEET NORTH AND 1640 FEET EAST FROM THE NW CORNER OF DLC 64.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:


