confirms the right to store the waters of JACK CREEK AND ANTELOPE CREEK, tributaries JORDAN CREEK, AND JORDAN CREEK, a tributary of OWYHEE RIVER, in ANTELOPE RESERVOIR, appropriated under Permit 10843, for IRRIGATION AND SUPPLEMENTAL IRRIGATION.
