confirms the right to use the water of SNAKE RIVER a tributary of COLUMBIA RIVER for IRRIGATION of 107.0 ACRES.

The right was perfected under Permit 6742 and the date of priority is MAY 25, 1925. The amount of water to which such right is entitled for the purpose aforesaid is limited to an amount actually beneficially used for said purpose and shall not exceed 1.338 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows: LOT 3 (SW¼ NW¼) SECTION 28, T 19 S, R 47 E, W.M.; 2560 FEET SOUTH AND 980 FEET EAST FROM THE NW CORNER OF SECTION 28.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
