CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BILL BOTELHO
HC 60 BOX 530
LAKEVIEW, OR 97630

confirms the right to use the waters of A WELL in the GOOSE LAKE BASIN for IRRIGATION OF 440.1 ACRES; BEING 102.6 ACRES PRIMARY AND 337.5 ACRES SUPPLEMENTAL.

This right was perfected under Permit G-9165. The date of priority is NOVEMBER 20, 1980. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 5.14 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The well is located as follows:

SW 1/4 SE 1/4, SECTION 30, T 38 S, R 20 E, W.M.; 1240 FEET NORTH AND 2620 FEET WEST FROM THE SOUTHEAST CORNER OF SECTION 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, provided further that the amount of water rediverted from the channel of THOMAS CREEK shall not exceed the amount by which the flow of THOMAS CREEK is increased above the natural flow by the operation of the well.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



The user shall install and maintain a weir, meter or other suitable measuring device and shall keep a complete record of the amount of ground water withdrawn.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
