CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TURNER RANCH INC. ROUTE 2, BOX 2218 HEPPNER, OREGON 97836

confirms the right to use the waters of TWO WELLS in the SAND HOLLOW BASIN for IRRIGATION OF 318.5 ACRES.

This right was perfected under Permit G-4255. The date of priority is JULY 25, 1968. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.55 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The wells are located as follows:

NE 1/4 SW 1/4, SECTION 26, T 1 N, R 26 E, WM; 420 FEET SOUTH AND 1400 FEET EAST FROM THE W 1/4 CORNER, SECTION 26.

SW 1/4 SW 1/4, SECTION 26, T 1 N, R 26 E, WM; 2600 FEET SOUTH AND 30 FEET EAST FROM THE W 1/4 CORNER, SECTION 26.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
