CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILLIAM C. WOOLEY AND NONDYS WOOLEY 1665 SMITH RIVER ROAD DRAIN, OREGON 97435

confirms the right to use the waters of AN UNNAMED STREAM AND RESERVOIR CONSTRUCTED UNDER PERMIT R-6266, a tributary of PASS CREEK, for PRIMARY IRRIGATION OF 5.9 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 4.5 ACRES.

This right was perfected under Permit 39117. The date of priority is APRIL 30, 1973. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.07 CUBIC FOOT PER SECOND FROM DIRECT FLOW AND 6.55 ACRE FEET STORED WATER ONLY FOR LANDS DESCRIBED AS SUPPLEMENTAL or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE% SE%, SECTION 33, T 21 S, R 5 W, W.M.; 650 FEET NORTH AND 350 FEET WEST FROM THE SE CORNER OF SECTION 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate correctly describes and replaces that portion of the water right confirmed by Certificate 75609, which replaced Certificate 65174, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered April 30, 1998, approving Transfer Application 7906.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
