CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GUY BARTON ROUTE 2, BOX 838 KLAMATH FALLS, OREGON 97601

confirms the right to use the waters of A WELL in the LOST RIVER BASIN for IRRIGATION AND SUPPLEMENTAL IRRIGATION OF 153.6 ACRES.

This right was perfected under Permit U-302. The date of priority is SEPTEMBER 16, 1949. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.92 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW¼ SE¼, SECTION 33, T 38 S, R 11½ E, W.M.; 19½ CHAINS NORTH AND 55½ CHAINS EAST FROM THE SW CORNER OF SECTION 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

Township 33 South, Range 11½ East, W.M.

This use may be regulated if analysis of data available discloses that the appropriation will measurably reduce the surface water flows necessary to maintain the free-flowing character of a scenic waterway in quantities necessary for recreation, fish and wildlife in effect as of the priority date of this right or as those quantities may be subsequently reduced.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
