confirms the right to use the waters of **TERAMURA WELL # 2**, in the SNAKE RIVER BASIN for for the purpose of **SUPPLEMENTAL IRRIGATION of 93.8 ACRES.**

This right was perfected under Permit G-789. The date of priority is **FEBRUARY 13, 1958**. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed **1.2 CUBIC FEET PER SECOND** or its equivalent in case of rotation, measured at the point of appropriation from the source.

The point of appropriation is located as follows:

SW1/4 SE1/4, SECTION 23, T. 18 S., R. 46 E., W.M.; 325 FEET NORTH and 2000 FEET WEST from the SE corner of SECTION 23.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to **ONE-EIGHTIETH** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **3 acre-feet** for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
