CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STEVEN HANSEN
4661 POWER ROAD
ONTARIO, OREGON 97914

confirms the right to use the waters of **JACOBSEN GULCH**, tributary of SNAKE RIVER for the purpose of **SUPPLEMENTAL IRRIGATION of 35.9 ACRES.**

This right was perfected under Permit 37274. The date of priority is **NOVEMBER 9, 1970.** The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed **2.94 CUBIC FOOT PER SECOND** or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW¼ SE¼, SECTION 7, T. 17 S., R. 47 E., W.M.; 1060 FEET SOUTH AND 720 FEET EAST from center of SECTION 7

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to **ONE-FORTIETH** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **4 acre-feet** for each acre irrigated during the irrigation season of each year, and is subject to the terms and conditions of an agreement, or a satisfactory replacement, between the Owyhee Irrigation District and the applicant dated February 14, 1972, a copy of which is on file in the office of the Water Resources Director, and by reference made a part hereof. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

All Townships are South, all Ranges are East, location in reference to Willamette Meridian

This Certificate describes the water right confirmed by Certificate 48052 State Record of Water Right Certificates, ~~NOT~~ modified by the provisions of an order of the Water Resources Director entered on JAN 25 1999 approving a petition by the Owyhee Irrigation District under ORS 541.329. This Certificate together with Certificate 75706 supersedes Certificate 48052.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use herein described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream water rights.
