CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JIM AND MARTHA KYLES
5109 HYLINE ROAD
ONTARIO, OREGON 97914

confirms the right to use the waters of **UNNAMED INTERMITTENT DRAINAGEWAY AND A RESERVOIR CONSTRUCTED UNDER PERMIT R-7026**, tributary of SNAKE RIVER for the purpose of **IRRIGATION of 22.3 ACRES**.

This right was perfected under Permit 42862. The date of priority is **SEPTEMBER 30, 1977**. This right is limited to **0.21 CUBIC FOOT PER SECOND** or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE $\frac{1}{4}$ SE $\frac{1}{4}$, SECTION 17, T. 16 S., R. 47 E., W.M.; 1180 FEET SOUTH AND 1050 FEET WEST FROM THE E $\frac{1}{4}$ CORNER SECTION 17.

The amount of water used for irrigation from direct flow and storage, together with the amount secured under any other right existing for the same lands, is limited to **ONE-FORTIETH** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **4 acre-feet** for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


NE $\frac{1}{4}$ SE $\frac{1}{4}$ TAX LOT 6700 22.3 ACRES
SECTION 17
TOWNSHIP 16 SOUTH, RANGE 47 EAST, W.M.

This Certificate describes the water right confirmed by Certificate 60611 State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on JAN 25 1999 approving a petition by the Owyhee Irrigation District under ORS 541.329. This Certificate together with Certificate 75713 supersedes Certificate 60611.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use herein described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream water rights.
