CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHARLES WARREN FARMER JR. & JAMES GERALD FARMER P.O. BOX 1585 NYSSA, OREGON 97913

confirms the right to use the waters of UNNAMED WASTE DITCH AND LOCKET GULCH, tributary of SNAKE RIVER for the purpose of SUPPLEMENTAL IRRIGATION of 264.6 ACRES FROM UNNAMED WAST DITCH AND 12.0 ACRES FROM LOCKET GULCH.

This right was perfected under Permit 49889. The date of priority is JUNE 4, 1986 This right is limited to 1594.4 GALLONS PER MINUTE (3.55 CFS), BEING 1500 GPM FROM WASTE DITCH AND 94.4 GPM FROM LOCKET GULCH or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

WASTE DITCH: SW¹/₄ NE¹/₄, Section 11, Township 20 S., Range 46 E., W.M., being 1490 feet South & 140 feet East from N¹/₄ corner Section 11.

LOCKET GULCH: SE¹/₄ NW¹/₄, Section 12, Township 20 S., Range 46 E., W.M., being 1880 feet South and 2550 feet East from the NW corner of Section 12.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to **ONE-FORTIETH** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **4 acre-feet** for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
