CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STAN ADAMS

confirms the right to use the waters of 2 WELLS in the FORT ROCK BASIN for IRRIGATION of 148.2 ACRES.

This right was perfected under Permit G-7364. The date of priority is FEBRUARY 9, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.849 CUBIC FEET PER SECOND being 0.616 cfs from WELL #1 and 1.233 cfs from WELL #2 or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

NE $\frac{1}{4}$ SW $\frac{1}{4}$, SW $\frac{1}{4}$ SE $\frac{1}{4}$, SECTION 34, T 27 S, R 16 E, W.M.; WELL #1 - 30 feet SOUTH and 1360 feet EAST from the W $\frac{1}{4}$ CORNER, WELL #2 - 1230 feet NORTH and 2000 feet WEST from the SE CORNER, both SECTION 34.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SE $\frac{1}{4}$ SW $\frac{1}{4}$	29.4 ACRES
SW $\frac{1}{4}$ SE $\frac{1}{4}$	28.7 ACRES
SE $\frac{1}{4}$ SE $\frac{1}{4}$	28.6 ACRES

SECTION 34

TOWNSHIP 27 SOUTH, RANGE 16 EAST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 54690, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered JUL 02 1998, approving Transfer Application 7972.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
