CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELL 2 in the UMATILLA RIVER BASIN for IRRIGATION of 3.2 ACRES and DUST CONTROL.

This right was perfected under Permit G-3034. The date of priority is SEPTEMBER 7, 1965. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.94 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE½ SW¼, SECTION 22, T 4 N, R 28 E, WM; 10 FEET NORTH AND 1330 FEET EAST FROM THE SW CORNER, SECTION 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
