CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VERLIN K. HERMANN

confirms the right to use the waters of the SOUTH FORK COQUILLE RIVER, a tributary of the COQUILLE RIVER, for IRRIGATION OF 17.1 ACRES, STOCK, AND FIRE PROTECTION.

This right was perfected under Permit 29235. The date of priority is NOVEMBER 12, 1963. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.224 CUBIC FOOT PER SECOND (CFS); BEING 0.214 CFS FOR IRRIGATION, 0.005 CFS FOR STOCK, AND 0.005 CFS FOR FIRE PROTECTION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 9 (NW¼ NE¼), SECTION 5, T 30 S, R 12 W, W.M.; 840 FEET SOUTH AND 750 FEET EAST FROM THE N¼ CORNER OF SECTION 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

LOT 9 (NW¼ NE¼) 12.1 ACRES AND STOCK  
NE¼ NW¼ 5.0 ACRES AND FIRE PROTECTION  
SECTION 5  
TOWNSHIP 30 SOUTH, RANGE 12 WEST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 34441, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered NOV 19 1998, approving Transfer Application 7394.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
