CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MARILYN SMITH

JOHN DAY, OREGON 97845

confirms the right to use the waters of JOHN DAY RIVER, a tributary of COLUMBIA RIVER, for IRRIGATION OF 29.6 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for GRANT COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at Page 461. The date of priority is 1873.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1/40 CUBIC FOOT PER SECOND PER ACRE IRRIGATED FROM APRIL 1 TO SEPTEMBER 30; FURTHER LIMITED TO ONE ACRE FOOT PER ACRE PER CALENDAR MONTH TO JULY 1 AND 3/4 ACRE FOOT PER ACRE THEREAFTER; TOTAL FIVE ACRE FEET PER ACRE FOR SEASON, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

PANAMA DITCH - NE 1/4 NW 1/4, SECTION 25, TOWNSHIP 13 SOUTH, RANGE 30 EAST, WM, 390 FEET SOUTH AND 2100 FEET EAST FROM THE NW CORNER, SECTION 25;

PUMP - NE 1/4 NE 1/4, SECTION 26, TOWNSHIP 13 SOUTH, RANGE 30 EAST, WM, 1830 FEET NORTH AND 300 FEET WEST FROM THE E 1/4 CORNER, SECTION 26.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 SE 1/4 12.3 ACRES
SE 1/4 SE 1/4 10.3 ACRES
SECTION 23

NW 1/4 NW 1/4 7.0 ACRES
SECTION 25
TOWNSHIP 13 SOUTH, RANGE 30 EAST, WM

When in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

The diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the water user is entitled; and

The type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.



This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered JULY 9, 1980, along with Certificate 49674 supersedes Certificate 33252, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
