CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HERITAGE RANCH
ROUTE 2 BOX 177
BAKER CITY, OR 97814

confirms the right to use the waters of ONE SUMP WELL (TOGETHER WITH DRAINS OUTLETING INTO THE SUMP) in the POWDER RIVER BASIN for PRIMARY IRRIGATION OF 226.7 ACRES AND SUPPLEMENTAL IRRIGATION OF 64.4 ACRES.

This right was perfected under Permit G-9380. The date of priority is FEBRUARY 3, 1981. This right is limited to 2.36 CUBIC FEET PER SECOND (CFS), BEING 1.68 CFS FOR PRIMARY IRRIGATION AND 0.68 CFS FOR SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE 1/4 NE 1/4, SECTION 6, T 8 S, R 40 E, W.M.; 1270 FEET SOUTH AND 470 FEET WEST FROM THE NE CORNER OF SECTION 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


