## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NORMAN BUTLER ROUTE 1 BAKER, OREGON 97814

confirms the right to use the waters of THREE GRAVEL PITS in the PINE CREEK (POWDER RIVER) BASIN for IRRIGATION OF 61.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 120.6 ACRES.

This right was perfected under Permit G-2877. The date of priority is APRIL 14, 1965. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.25 CUBIC FEET PER SECOND; being 1.32 CUBIC FEET PER SECOND FROM PIT NO. 1; 0.72 CFS FROM PIT NO. 2; AND 0.21 CUBIC FOOT PER SECOND FROM PIT NO. 3 or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

#1 - 680 FEET SOUTH AND 770 FEET WEST from the E% CORNER, SECTION 19; #2 - 1930 FEET NORTH AND 600 FEET EAST; #3 - 700 FEET SOUTH AND 190 FEET EAST; both from the W% CORNER, SECTION 29, being within #1 - NE% SE%, SECTION 19; #2 - NW% NW%; #3 - NW% SW%, SECTION 29, T 8 S, R 39 E, WM, in the county of Baker.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
