CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

J. IRA MCNUTT 351½ EAST BROADWAY EUGENE, OREGON 97401

confirms the right to use the waters of the MCKENZIE RIVER, a tributary of the WILLAMETTE RIVER, for IRRIGATION OF 105.9 ACRES.

This right was perfected under Permit 14388. The date of priority is JULY 25, 1940. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.33 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW½ NW½, AS PROJECTED WITHIN JAMES W. STORMENT DLC 40, SECTION 26, T 17 S, R 1 W, W.M..

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
