## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of EAGLE CREEK, a tributary of POWDER RIVER, for IRRIGATION OF 21.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for BAKER COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at Page 291. The date of priority is 1887 FOR TRACT 1 AND 1885 FOR TRACT 2.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.53 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

TRACT 1 - MOODY DITCH - 2130 FEET NORTH AND 650 FEET EAST FROM THE SW CORNER OF SECTION 3, T 9 S, R 45 E W.M..

TRACT 2 - NEWT YOUNG DITCH - 1950 FEET SOUTH AND 1400 FEET EAST FROM THE NW CORNER OF SECTION 33, T 8 S, R 45 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.
