CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN MULHOLLAND ROUTE 3, BOX 285B GASTON, OREGON 97119

confirms the right to use the waters of BLACK JACK CREEK, DAIRY WASTE AND WASTE LAGOON CONSTRUCTED UNDER PERMIT R-7935, tributaries of TUALATIN RIVER, for the purpose of SUPPLEMENTAL IRRIGATION OF 247.7 ACRES AND DAIRY BARN USE.

This right has been perfected under Permit 44405. The date of priority is JUNE 18, 1979. This right is limited to 1.64 CUBIC FEET PER SECOND(CFS); BEING 1.36 CFS FROM DAIRY BARN WASTE AND WASTE LAGOON FOR SUPPLEMENTAL IRRIGATION, 0.28 CFS FROM BLACK JACK CREEK DURING THE NON-IRRIGATION SEASON (OCTOBER 1 THROUGH APRIL 30 OF EACH YEAR) AND 0.28 CFS FROM DAIRY WASTE AND WASTE LAGOON FOR DAIRY BARN USE or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:.

BLACK JACK CREEK - NE 1/4 NW 1/4, SECTION 34, T 1 S, R 4 W, W.M.; 1340 FEET NORTH AND 1050 FEET EAST FROM THE SE CORNER OF DLC 50; AND

DAIRY BARN WASTE AND WASTE LAGOON - NE 1/4 NW 1/4, SECTION 34, T 1 S, R 4 W, W.M.; 17000 FEET NORTH AND 1180 FEET EAST FROM THE SE CORNER OF DLC 50.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year from direct flow and storage.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
