CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DIAMOND PROPERTIES INVESTMENT COMPANY, LLC IONE, OREGON 97843

confirms the right to use the waters of WILLOW CREEK, a tributary of the COLUMBIA RIVER, for IRRIGATION of 150.0 ACRES and DOMESTIC (STOCK) USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for MORROW County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 1, at Page 73. The dates of priority are 1884 for DOMESTIC (STOCK) USE; 1892 for IRRIGATION of 84.73 ACRES; 1906 for IRRIGATION of 65.27 ACRES.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.41 CUBIC FEET PER SECOND with priority date of 1892, and 1.09 CUBIC FEET PER SECOND with priority date of 1906, if available at the original point of diversion; EWING, HIGHLINE, DESERTLAND, KIRTZLER, UNDERGROUND, AND MURPHY DITCHES, or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:
