CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of LITTLE PINE CREEK, a tributary of the JOHN DAY RIVER, for IRRIGATION OF 5.4 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for GRANT COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at page 461. The date of priority is 1888.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed ONE-FORTIETH OF ONE CUBIC FOOT PER SECOND PER ACRE IRRIGATED TO JUNE 1 AND ONE-EIGHTIETH OF ONE CUBIC FOOT PER SECOND PER ACRE THEREAFTER; FURTHER LIMITED TO 1.0 ACRE-FOOT PER CALENDAR MONTH TO JUNE 1 AND 4.0 ACRE-FEET PER ACRE DURING SEASON APRIL 1 TO SEPTEMBER 30, MEASURED AT POINT OF POINT OF DIVERSION.

The point of diversion is located as follows:

NE 1/4 NE 1/4, SECTION 7, T 14 S, R 32 E, W.M.; BARNARD DITCH - 580 FEET SOUTH AND 70 FEET WEST FROM THE NE CORNER OF SECTION 7.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 SE 1/4 1.1 ACRES  
SW 1/4 SE 1/4 1.9 ACRES  
SE 1/4 SE 1/4 0.1 ACRE  
SECTION 31  
TOWNSHIP 13 SOUTH, RANGE 32 EAST, W.M.


LOT 4 (SW 1/4 NW 1/4) 2.3 ACRES  
SECTION 5  
TOWNSHIP 14 SOUTH, RANGE 32 EAST, W.M.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered SEPTEMBER 8, 1980, and together with Certificate 49679, supersedes Certificate 25765, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
