CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JCK LEASING, LLC  
P.O. BOX 308  
STAYTON, OREGON 97383

confirms the right to use the waters of a SUMP WELL in the NORTH SANTIAM RIVER BASIN for IRRIGATION of 42.6 ACRES and SUPPLEMENTAL IRRIGATION of 25.5 ACRES.

This right was perfected under Permit G-1255. The date of priority is FEBRUARY 19, 1959. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.86 CUBIC FOOT PER SECOND, if available at the original point of appropriation: NW¼ SW¼, SECTION 15, T 9 S, R 1 W, WM; 26 CHAINS NORTH AND 25 CHAINS WEST FROM THE S¼ CORNER, SECTION 15, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE¼ SW¼, SECTION 15, T 9 S, R 1 W, WM; 1250 FEET NORTH AND 910 FEET WEST FROM THE S¼ CORNER, SECTION 15.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2¼ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
