CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MICHAEL D. BROCHU 259 SOUTH MYRTLE CREEK ROAD MYRTLE CREEK, OREGON 97457

confirms the right to use the waters of SOUTH MYRTLE CREEK, a tributary of the SOUTH UMPQUA RIVER, for IRRIGATION OF 0.35 ACRE AND LAUNDRY FACILITIES.

This right was perfected under Permit 35055. The date of priority is APRIL 14, 1970. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.011 CUBIC FOOT PER SECOND (CFS), BEING 0.006 CFS FOR IRRIGATION AND 0.005 CFS FOR LAUNDRY FACILITIES, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW½ NE½, SECTION 23, T 29 S, R 4 W, W.M.; 1600 FEET SOUTH AND 170 FEET EAST FROM N½ CORNER OF SECTION 23.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW% NE% 0.35 ACRE AND LAUNDRY FACILITIES SECTION 23
TOWNSHIP 29 SOUTH, RANGE 4 WEST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 42809, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered ______APR 27 1999 _____, approving Transfer Application 6945.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
