CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

F.W. McCAFFERY, RACHAEL McCAFFERY and JOHN W. DENNIS SISTERS, OREGON 97759

confirms the right to use the waters of SQUAW CREEK, a tributary of the DESCHUTES RIVER, for IRRIGATION of 74.1 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for CROOK County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 1, at Page 433. The date of priority is 1885.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.48 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SMITH DITCH.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FIFTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:
