confirms the right to use the waters of 2 WELLS in the FORT ROCK BASIN for IRRIGATION of 139.0 ACRES.

This right was perfected under Permit G-9020. The date of priority is JUNE 11, 1980. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.74 CUBIC FEET PER SECOND, being 0.09 cfs from WELL 1 and 1.65 cfs from WELL 2 or its equivalent in case of rotation, measured at the well.

The well is located as follows:
