confirms the right to use the waters of Eagle Creek, a tributary of POWDER RIVER for IRRIGATION of 210.00 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for BAKER COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at Page 291.

The date of priority is 1879. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 5.25 CUBIC FEET PER SECOND or the equivalent in case of rotation.

The point of diversion is located as follows:

Nash Ditch 590 feet North and 2720 feet East from SW corner Section 10, being within SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 10, T9S, R45E, WM.

The amount of water used for irrigation is limited to ONE-FORTIETH of one cubic foot per second per acre, or the equivalent, and shall be subject to all other conditions and limitations contained in said decree.

A description of the place of use to which this right is appurtenant is as follows:



This certificate describes that portion of the water right confirmed by Certificate 49640, issued in the name of E. A. Whittier, State Record of Water Right Certificates, NOT modified by the provisions of orders of the Water Resources Director entered on FEB 16 1999 approving petitions by the Dry Gulch Ditch Company and the Waterbury - Allen Ditch Improvement District and under ORS 541.329. This certificate, together with certificates 75363 and 75355, supersedes Certificate 49633.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
