confirms the right to use the waters of MCKAY CREEK, a tributary of the UMATILLA RIVER, for IRRIGATION OF 11.71 ACRES, DOMESTIC AND LIVESTOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Page 127. The date of priority is 1894.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.144 CUBIC FOOT PER SECOND, if available at the original point of diversion, NW $\frac{1}{2}$ NE $\frac{1}{2}$, Section 28, T 2 N, R 32 E, WM; French Ditch - 300 Feet South and 1550 Feet West from the NE Corner, Section 21.

The points of diversion are located as follows:

SW¼ SE¼, NW¼ SE¼, SECTION 21, T 2 N, R 32 E, WM; 1 - 180 FEET NORTH AND 680 FEET EAST; 2 - 770 FEET NORTH AND 290 FEET EAST; 3 - 1980 FEET NORTH AND 80 FEET EAST; ALL FROM THE S¼ CORNER, SECTION 21.

A description of the place of use to which this right is appurtenant is as follows:
