## CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO

W. F. KING, OLIVER POWELL, AND ARTHUR R. MINKLER PRINEVILLE, OREGON 97754

confirms the right to use the waters of OCHOCO CREEK, a tributary of THE CROOKED RIVER, for IRRIGATION of 411.2 ACRES.

This right was perfected under Enlargement Permit 24. The date of priority is DECEMBER 1, 1909. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 5.14 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
