## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GLENN J. AND JERILYNN BARTON 10341 NIGHTINGALE AVE. FOUNTAIN VALLEY, CA 92708

confirms the right to use the waters of ROGUE RIVER, a tributary of PACIFIC OCEAN, for PRIMARY IRRIGATION OF 0.4 ACRE AND SUPPLEMENTAL IRRIGATION OF 1.7 ACRES.

This right was perfected under Permit 50424. The date of priority is AUGUST 29, 1988. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.026 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SE 1/4, SECTION 35, TOWNSHIP 33 SOUTH, RANGE 1 WEST, W.M.; 490 FEET SOUTH AND 410 FEET WEST FROM E 1/4 CORNER, SECTION 35.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
