#### CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROBERT ZIELINSKI ROUTE 1, BOX 59 GERVAIS, OREGON

confirms the right to use the waters of TWO WELLS in the WILLAMETTE RIVER BASIN for IRRIGATION OF 79.8 ACRES AND SUPPLEMENTAL IRRIGATION OF 23.6 ACRES.

This right was perfected under Permit G-2954. The date of priority is FEBRUARY 15, 1965. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.29 CUBIC FOOT PER SECOND (CFS), BEING 0.37 CFS FROM WELL 1 AND 0.92 CFS FROM WELL 2, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

WELL 1 - NW¼ SW¼, AS PROJECTED WITHIN LADTROOTE DLC 52, SECTION 31, T 5 S, R 2 W, W.M.; 980 FEET NORTH AND 1410 FEET EAST FROM THE SW CORNER OF HAGEY DLC 69.

WELL 2 - NE% SE%, AS PROJECTED WITHIN LADTROOTE DLC 52, SECTION 31, T 5 S, R 2 W, W.M.; 710 FEET NORTH AND 3300 FEET EAST FROM THE SW CORNER OF HAGEY DLC 69.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
