confirms the right to use the water of SPRING, a tributary of the COLUMBIA RIVER, for SUPPLEMENTAL IRRIGATION OF 15.8 ACRES AND STOCK USE.

The right was perfected under Permit No. 28356 and the date of priority is MARCH 28, 1962. The amount of water to which such right is entitled for the purpose aforesaid is limited to an amount actually beneficially used for said purpose and shall not exceed 0.285 CUBIC FOOT PER SECOND, BEING 0.28 CFS FOR SUPPLEMENTAL IRRIGATION AND 0.005 CFS FOR STOCK, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located in the NE¼ NW¼, SECTION 22, T 5 N, R 27 E, WM. Spring located: 1090 feet South and 1440 feet East from the NW Corner of Section 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent, for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
