## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN H. DERKSEN & OTTO L. WEINHOLD SALEM, OR 97302

confirms the right to use the water of an UNNAMED SPRING, a tributary of BATTLE CREEK, for DOMESTIC USE FOR TWO FAMILIES, STOCK USE ONLY DURING THE IRRIGATION SEASON OF EACH YEAR, AND THE IRRIGATION OF 10.5 ACRES.

The right was perfected under Permit No. 1927 and the date of priority is FEBRUARY 2, 1914. The amount of water to which such right is entitled for the purposes aforesaid is limited to an amount actually beneficially used for said purposes and shall not exceed 0.154 CUBIC FOOT PER SECOND, BEING 0.01 CFS FOR DOMESTIC, 0.013 CFS FOR STOCK, AND 0.131 CFS FOR IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located in the NW¼ SW¼, SECTION 30, T 8 S, R 2 W, WM. Spring located: 1650 feet North and 760 feet West from the NE Corner of Delaney DLC 64.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent, for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
