CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LARRY MENTEER  
PO BOX 81  
ROGUE RIVER, OREGON 97537

confirms the right to use the waters of EVANS CREEK, a tributary of THE ROGUE RIVER, for IRRIGATING 4.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at Page 1. The date of priority is 1896.

The use is limited to 0.051 CUBIC FOOT PER SECOND, NOT TO EXCEED 21.61 ACRE-FEET OF WATER EACH YEAR, if available at the original point of diversion of the WILLIAMS AND WHALEN DITCH, or its equivalent in case of rotation, measured at the point of diversion from the source.

The quantity of water diverted at the new point of diversion, shall not exceed the quantity of water available at the original point of diversion.

The point of diversion is located as follows:

NW 1/4 SW 1/4, SECTION 11, T 35 S, R 4 W, W.M.; 370 FEET NORTH AND 80 FEET WEST FROM THE SE CORNER OF THE NW 1/4 SW 1/4 OF SECTION 11.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SW 1/4 1.9 ACRES  
SE 1/4 SW 1/4 2.1 ACRES  
SECTION 11  
TOWNSHIP 35 SOUTH, RANGE 4 WEST, W.M.


When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a CONSERVATION PROJECT approved by an order of the Water Resources Director entered JANUARY 6, 1999, and together with Certificate 76035, supersedes Certificate 68635, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
