CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Z X RANCH

confirms the right to use the waters of WELLS 2 AND 3 in the SILVER LAKE BASIN for SUPPLEMENTAL IRRIGATION OF 185.71 ACRES.

This right was perfected under Permit G-8121. The date of priority is APRIL 4, 1978. This right is limited to 2.32 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

WELL 2 - NW 1/4 NE 1/4, SECTION 26, T 28 S, R 14 E, W.M.; 728 FEET SOUTH AND 3144 FEET EAST FROM THE NW CORNER OF SECTION 26; AND

WELL 3 -NW 1/4 NW 1/4, SECTION 25, T 28 S, R 14 E, W.M.; 688 FEET SOUTH AND 1166 FEET EAST FROM THE NW CORNER OF SECTION 25.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 NW 1/4	38.20 ACRES
SE 1/4 NW 1/4	12.79 ACRES
NE 1/4 SW 1/4	35.13 ACRES
NW 1/4 SW 1/4	39.00 ACRES
SW 1/4 SW 1/4	30.70 ACRES
SE 1/4 SW 1/4	29.89 ACRES

SECTION 25

TOWNSHIP 28 SOUTH, RANGE 14 EAST, W.M.

The quantity of water diverted at the new point of appropriation shall not exceed the quantity of water available from the original points of appropriation.

The well at the new point of appropriation shall be maintained to the well construction standards in effect as of May 10, 1991, and must include an access port.

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.



This certificate is issued to confirm a change in POINT OF APPROPRIATION AND PLACE OF USE approved by an order of the Water Resources Director entered MAY 10, 1991, and together with Certificate 65757, supersedes Certificate 50756, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
