## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RUSSELL H. AND JESSIE E. PARKER 904 N. ALBANY ROAD ALBANY, OR 97321

confirms the right to use the water of a WELL, a tributary of the WILLAMETTE RIVER for SUPPLEMENTAL IRRIGATION of 21.1 ACRES.

The right was perfected under Permit G-2436 and the date of priority is JULY 17, 1963. The amount of water to which such right is entitled for the purpose aforesaid is limited to an amount actually beneficially used for said purpose and shall not exceed 0.26 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The well is located in the NW1/4 NW1/4, as projected within G. Adkins DLC 79, Section 31, T10S, R3W, WM;1880 FEET NORTH AND 1480 FEET WEST FROM THE SE CORNER DLC 79.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, shall be further limited to a diversion of not to exceed 21/2 acre feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
