CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICHARD L. AND SANDRA M. TWIGG  
dba TWIGG FARM

confirms the right to use the waters of a RESERVOIR, constructed under Permit R-1932, a tributary of the TUALATIN RIVER, for SUPPLEMENTAL IRRIGATION OF 55.5 ACRES.

This right was perfected under Permit 24482. The date of priority is SEPTEMBER 26, 1956. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 10.0 ACRE FEET, provide the total diverted under all rights perfected under Permit 24483 shall not exceed 10.0 acre feet, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE $\frac{1}{4}$  SW $\frac{1}{4}$ , SECTION 36, T 1 S, R 3 W, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited a diversion of 2 $\frac{1}{2}$  acre feet per acre or its equivalent for each acre irrigated during the irrigation season of each year, and shall be further limited to a total diversion of not to exceed 10.0 acre feet per year for all rights perfected under Permit 24482.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE $\frac{1}{4}$  SW $\frac{1}{4}$       30.0 ACRES  
SE $\frac{1}{4}$  SW $\frac{1}{4}$       25.5 ACRES  
SECTION 36  
TOWNSHIP 1 SOUTH, RANGE 3 WEST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 26845, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered                     MAR 24 1999                    , approving Transfer Application 7207.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
