CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN F. WALCHLI ROUTE 3, BOX 342 HERMISTON, OREGON 97838

confirms the right to use the waters of AN UNNAMED STREAM, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 281.9 ACRES and SUPPLEMENTAL IRRIGATION OF 335.4 ACRES.

This right was perfected under Permit 30373. The date of priority is JANUARY 21, 1965. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 4.14 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW¼ NE¼, SECTION 4, T 4 N, R 29 E, W.M.; 1040 FEET NORTH AND 1540 FEET WEST FROM THE E¼ CORNER, SECTION 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
