## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GENE PORTER HC 84 BOX 100 SILVER LAKE, OREGON 97638

confirms the right to use the waters of A WELL in the FORT ROCK BASIN for IRRIGATION of 78.76 ACRES.

This right was perfected under Permit G-10219. The date of priority is SEPTEMBER 1, 1983. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.98 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE½ NE½, SECTION 2, T 27 S, R 15 E, W.M.; 2450 feet SOUTH and 600 feet WEST from the NE CORNER SECTION 2.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. IN THE EVENT OF A REQUEST FOR A CHANGE IN POINT OF APPROPRIATION, AN ADDITIONAL POINT OF APPROPRIATION OR REPAIR OF THIS WELL, THE QUANTITY OF WATER ALLOWED HEREIN TOGETHER WITH ANY OTHER RIGHT FROM THIS POINT OF APPROPRIATION SHALL NOT EXCEED THE CAPACITY OF THIS WELL AT THE TIME OF PERFECTION OF THIS RIGHT.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

LOT 4 (NW¼ NW¼) 38.76 ACRES SW¼ NW¼ 40.00 ACRES SECTION 1 TOWNSHIP 27 SOUTH, RANGE 15 EAST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 58871, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered, approving Transfer Application 8129.
The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
