CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WALLACE STANCIU AND LORIN STANCIU 41580 STANCIU ROAD RICHLAND, OREGON 97870

confirms the right to use the waters of SPRING 1 AND SPRING 2, tributaries of STRANG GULCH, for PRIMARY IRRIGATION OF 0.5 ACRE, SUPPLEMENTAL IRRIGATION OF 7.0 ACRES, DOMESTIC USE FOR ONE FAMILY AND STOCK WATER.

This right was perfected under Permit 47517. The date of priority is MARCH 19, 1983. This right is limited to 0.06 CUBIC FOOT PER SECOND(CFS), BEING 0.04 CFS FROM SPRING 1 FOR IRRIGATION, 0.01 CFS FOR DOMESTIC USE FOR ONE FAMILY (0.005 CFS FROM EACH SPRING), AND 0.01 CFS FOR STOCK WATER (0.005 CFS FROM EACH SPRING), or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:

SPRING 1 - SE 1/4 SW 1/4, SECTION 24, T 9 S, R 44 E, W.M.; 75 FEET NORTH AND 3700 FEET WEST FROM THE SE CORNER OF SECTION 24; AND

SPRING 2 - SE 1/4 SW 1/4, SECTION 24, T 9 S, R 44 E, W.M.; 130 FEET NORTH AND 2900 FEET WEST FROM THE SE CORNER OF SECTION 24.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.5 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

PRIMARY SUPPLEMENTAL

NW 1/4 SE 1/4 0.5 ACRES 5.5 ACRES, DOMESTIC AND STOCK
SW 1/4 SE 1/4 1.5 ACRES

SECTION 19

TOWNSHIP 9 SOUTH, RANGE 45 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
