CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELL No. 2 in the UMATILLA RIVER BASIN, for IRRIGATION OF 1.8 ACRES AND SUPPLEMENTAL IRRIGATION OF 315.7 ACRES.

This right was perfected under Permit G-8036. The date of priority is SEPTEMBER 11, 1974. This right is limited to not more than 2.84 CUBIC FEET PER SECOND; or its equivalent in case of rotation, measured at the well.

The well is located as follows: SE¼ NW¼, SECTION 29, T 4 N, R 29 E, W.M.; 1050 FEET NORTH AND 640 FEET WEST FROM CENTER, SECTION 29.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
