confirms the right to use the waters of WELL #2 in the UMATILLA RIVER BASIN, for PRIMARY IRRIGATION OF 5.1 ACRES AND SUPPLEMENTAL IRRIGATION OF 154.9 ACRES.

This right was perfected under Permit U-575. The date of priority is AUGUST 12, 1953. This right is limited to not more than 2.0 CUBIC FEET PER SECOND; or its equivalent in case of rotation, measured at the well.

The well is located as follows: NE¼ SE¼, SECTION 13, T 4 N, R 29 E, W.M.; 1100 FEET SOUTH AND 1300 FEET WEST FROM E 1/4 CORNER, SECTION 13.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
