CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GLEN CHOWNING ROUTE 1, BOX 1109 HERMISTON, OREGON 97838

confirms the right to use the waters of A WELL in the UMATILLA RIVER BASIN, for PRIMARY IRRIGATION OF 15.3 ACRES AND SUPPLEMENTAL IRRIGATION OF 133.85 ACRES.

This right was perfected under Permit U-517. The date of priority is FEBRUARY 16, 1953, for 1.0 CUBIC FOOT PER SECOND and MARCH 10, 1953, for 0.01 CFS. This right is limited to not more than 1.01 CFS; or its equivalent in case of rotation, measured at the well.

The well is located as follows: NE¼ SE¼, SECTION 18, T 4 N, R 29 E, W.M.; 20.1 CHAINS NORTH AND 31.5 CHAINS EAST FROM S 1/4 CORNER, SECTION 18.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
