CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN F. WALCHLI  
ROUTE 3, BOX 342  
HERMISTON, OREGON 97838

confirms the right to use the waters of AN UNNAMED STREAM, a tributary of COLUMBIA RIVER, for PRIMARY IRRIGATION OF 11.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 605.9 ACRES.

This right was perfected under Permit 30373. The date of priority is JANUARY 21, 1965. This right is limited to not more than 4.14 CUBIC FEET PER SECOND; or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows: SW 1/4 NE 1/4, SECTION 4, T 4 N, R 29 E, W.M.; 1040 FEET NORTH AND 1540 FEET WEST FROM THE E 1/4 CORNER, SECTION 4.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
