CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DARRYL C. RAY
16837 HIGHWAY 138
OAKLAND, OR 97462

confirms the right to use the waters of A SPRING, AN UNNAMED STREAM AND UMPQUA RIVER, tributaries of PACIFIC OCEAN, for LIVESTOCK WATERING AND IRRIGATION OF 35.0 ACRES.

This right was perfected under Permit 51447. The date of priority is SEPTEMBER 5, 1991. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.46 CUBIC FOOT PER SECOND (CFS), BEING 0.01 CFS FROM SPRING AND 0.01 CFS FROM UNNAMED STREAM FOR LIVESTOCK AND 0.44 CFS FROM UMPQUA RIVER FOR IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SPRING - SW 1/4 NE 1/4, SECTION 33, T 23 S, R 7 W, W.M.; 20 FEET NORTH AND 1040 FEET EAST FROM THE NW CORNER OF DLC 38;

UNNAMED STREAM - NW 1/4 SW 1/4, SECTION 28, T 23 S, R 7 W, W.M.; 1970 FEET NORTH AND 1100 FEET EAST FROM THE SW CORNER OF SECTION 28; AND

UMPQUA RIVER: SW 1/4 SE 1/4, SECTION 28, T 23 S, R 7 W, W.M.; 900 FEET SOUTH AND 900 FEET EAST FROM THE NE CORNER OF DLC 39.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


Diversion screening or fish passage facilities shall be designed, installed, and operated to Oregon Department of Fish & Wildlife specifications.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
