## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VALE OREGON IRRIGATION DISTRICT 521 "A" STREET WEST VALE, OREGON 97918

confirms the right to use the waters of WILLOW CREEK, a tributary of MALHEUR RIVER for IRRIGATION OF 280.5 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Malheur County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Page 258. The dates of priority are 1871 for 150.0 acres (Tract 1), and 1873 for 130.5 acres (Tract 2).

The amount of water to which this right is entitled, is limited to an amount actually beneficially used for said purposes, and shall not exceed a total of 7.01 CUBIC FEET PER SECOND from February 15th to May 1st and 3.50 CUBIC FEET PER SECOND from May 1st to September 1st, if available at the authorized points of diversion, or the equivalent in case of rotation. The total quantity diverted during each irrigation season shall not exceed 841.5 ACRE FEET.

The points of diversion are located as follows:

LATERAL 385 - SE% SW%, Section 10, Township 16 South, Range 43 East, W.M.; 840 feet North and 180 feet West of the South 1/4 Corner of Section 10.

HAMMACK & MAAG DIVERSION - NE% NE%, Section 9, Township 16 South, Range 43 East, W.M.; 1304 feet South and 139 feet West from the NE Corner of Section 9.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second from February 15th to May 1st and ONE-EIGHTIETH of one cubic foot per second from May 1st to September 1st, or the equivalent for each acre irrigated during the irrigation season of each year.
