CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VALE OREGON IRRIGATION DISTRICT
521 "A" STREET WEST
VALE, OREGON 97918

confirms the right to use the waters of WILLOW CREEK, a tributary of MALHEUR RIVER for IRRIGATION OF 109.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Malheur County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Page 258. The dates of priority are 1871 for 50.0 acres (Tract 1), and 1873 for 59.0 acres (Tract 2).

The amount of water to which this right is entitled, is limited to an amount actually beneficially used for said purposes, and shall not exceed a total of 2.73 CUBIC FEET PER SECOND from February 15th to May 1st and 1.37 CUBIC FEET PER SECOND from May 1st to September 1st, if available at the authorized point of diversion, or the equivalent in case of rotation.

The point of diversion is located as follows:

LATERAL 379 - NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 9, Township 16 South, Range 43 East, W.M.; 30 feet South and 1190 feet West of the NE corner of Section 9.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second from February 15th to May 1st and ONE-EIGHTIETH of one cubic foot per second from May 1st to September 1st, or the equivalent for each acre irrigated during the irrigation season of each year. The total quantity diverted during each irrigation season shall not exceed 327.0 ACRE FEET.

A description of the place of use to which this right is appurtenant is as follows:



This certificate confirms an order of the director entered on November 4, 2002, and recorded in Special Order Volume 55, Page 2004, approving a petition by Vale Oregon Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate supersedes Certificate 56509.

The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
