CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

M.G. & I.W. HOPE VALE, OREGON

confirms the right to use the waters of KERN CREEK and TURNER CREEK, TRIBUTARIES OF WILLOW CREEK, and WILLOW CREEK a tributary of MALHEUR RIVER for IRRIGATION OF 1520.0 ACRES, DOMESTIC and STOCK. STORAGE from the waters of SPRING BRANCH, SHEEP CORRAL, CURRANT, and KERN CREEKS.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Malheur County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 8, at Page 228. The dates of priority are 1887 and 1904 for irrigation, and 1905 for storage.

The amount of water to which this right is entitled, is limited to an amount actually beneficially used for said purposes, and shall not exceed a total of 17.9 CUBIC FEET PER SECOND from February 15th to September 1st of each year, if available at the authorized point of diversion, or the equivalent in case of rotation. The total quantity diverted during each irrigation season shall not exceed 770.0 ACRE FEET.

The points of diversion are identified as follows:

Diversions #1, #2, #3, #4, #5, and #6.
