CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KENNETH V. and KATHLEEN G. KRUSE

confirms the right to use the waters of 3 WELLS in the BUCK CREEK BASIN for IRRIGATION OF 367.40 ACRES.

This right was perfected under Permit G-7361. The date of priority is APRIL 29, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 4.60 CUBIC FEET PER SECOND, being 0.74 cfs from WELL 1, 1.70 cfs from WELL 3, and 2.16 cfs from WELL 4, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

WELL 1 - NW¼ NE¼, SECTION 12, T 26 S, R 14 E W.M.; 17.1 CHAINS SOUTH and 22.8 CHAINS WEST from the NE CORNER of SECTION 12.

WELL 3 - NE¼ SE¼, SECTION 13, T 26 S, R 14 E, W.M.; 1330 FEET NORTH and 1310 FEET WEST from the SE CORNER, SECTION 13.

WELL 4 - NE¼ SE¼, SECTION 1, T 26 S, R 14 E, W.M.; 2300 FEET NORTH and 1310 FEET WEST From the SE CORNER, SECTION 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The following provision shall be effective when in the judgement of the Watermaster it becomes necessary to install measuring devices:

the pump system shall include an access port for measuring the water level;

the pump system shall include an in-line flow meter or other suitable device for measuring the water to which the user is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the measuring device be installed under the general supervision of said Watermaster.

This certificate describes that portion of the water right confirmed by Certificate 75331, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered JUN 14 1999, approving Transfer Application 8208.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
