CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LUCIOUS ROBINSON KERBY, OREGON

confirms the right to use the waters of EAST FORK ILLINOIS RIVER, a tributary of the ILLINOIS RIVER, AND ILLINOIS RIVER, a tributary of the ROGUE RIVER, for IRRIGATION OF 44.9 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JOSEPHINE County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 13, at Page 70. The date of priority is MAY, 1887.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed ONE CUBIC FOOT PER SECOND FOR EACH 50 ACRES OF LAND IRRIGATED DURING THE IRRIGATION SEASON FROM APRIL 1 TO NOVEMBER 1 OF EACH YEAR CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE% NW%, SECTION 27, T 39 S, R 8 W, W.M.; KERBYVILLE MILLING AND IRRIGATION COMPANY DITCH FOR TRACT 1 AND LOT 6(SE% SW%), SECTION 33, T 38 S, R 8 W, W.M.; 670 FEET NORTH AND 1560 FEET EAST FROM THE SW CORNER OF SECTION 33 FOR TRACT 2.
